Register to the Event through filling in the established sample of the application form and save it to the file, e.g. **Application Ivanov.doc.** 

Send your scientific note and application form to the organizing committee email: **tezy\_econ@ukr.net** by April 19, 2019. Make sure to receive confirmation of receiving the materials and payment emailed to tour address (it may take several days).

All the conference participants will get an electronic version of the conference proceedings and certificate.

Participants, taking part in the conference in person, receive the conference program and participant's certificate during the registration.

The electronic version of the conference proceedings will also be displayed on the Bila Tserkva NAU web-page, in the section "Conference proceedings".

#### PARTICIPATION FEE

Printed and on-line publication of the conference proceedings on the University web-site: for Ukrainians – 200 UAH; for international participants – free of charge.

# REQUIREMENTS FOR NOTES / ARTICLE

Scientific notes can be submitted in Ukrainian, Russian and English. The notes should be typed in a text editor of MS WORD 2000 or further version, format A4 (297x210 mm), pages not numbered. Volume -2-3 pages.

Page options: upper, lower and left margins – 30 mm, right margin 25 mm.

Heading: UDC index, author's surname and initials, institution name – are typed in a new line each, in the Times New Roman font, size 14 pt with a single line spacing and aligned with the left margin. The title of theses is placed 10 mm below the name of the organization, typed in capital letters in the font size 14 pt with a bold selection and aligned with the center.

The abstract in the Ukrainian language is typed 10 mm below the title, the paragraph indentation 10 mm in the Times New Roman font, size 14 pt with a single line spacing and text justified.

Keywords (up to 5 phrases) are mandatory, typed below the abstract.

The main text is 10 mm below the abstract, typed after a paragraph indentation of 10 mm in Times New Roman font, size 14 pt with a single line spacing and the text justified.

MS WORD formula editor should be used to type formulas (fonts: Symbol, Time New Roman; font size: normal 14 pt, large index 8 pt, small index 6 pt, large symbol 18 pt, small symbol 12 pt).

If the notes contain illustrations, they should be arranged in the text, the titles text (Figure 1. Scheme ...) justified; the paragraph indentation of 10 mm. Illustrations should be clear and contrasting.

Tables should be placed in text, their width should be 10 mm smaller than the width of the line. Above the table, put its number (Table 1), aligned with the right margin, under which to place the name of the table aligned with the center.

The bibliography is published in the general list at the end of the notes according to the requirements of DSTU 2015, typed 10 mm from the last line.

The conference participants and other interested persons can submit their scientific papers to publish in the "Economics and Management of AIC" journal of the Bila Tserkva NAU, published twice a year. The publication in the journal is free.
